After reviewing your file you may be asked for additional information. The law says that we have the right to ask you for this information before awarding Federal Student Aid.

As of 2012 IRS Federal Tax Return Transcripts or FAFSA IRS Data Retrieval is required for the Verification Process (more detail on Page 2). Signed copies of tax forms are not acceptable documentation.
