2014 IRS Data Retrieval (IRS DRT) through the FAFSA on the web is the best way to verify income. If the student and/or spouse <u>has not</u> already used the IRS DRT, follow these directions:

- 1) Go to <u>FAFSA.gov</u> log in to the student's FAFSA record, select "Make FAFSA Corrections,"
- 2) Navigate to the Financial Information section of the form. From there, follow the instructions to determine if the student and/ or spouse (if married) is eligible to use the IRS DRT.
 - It takes 2-3 weeks for IRS income information to be available for the IRS DRT for electronic IRS tax return filers, and 8-11 weeks for paper IRS tax return filers.
 - If you need more information about when, or how to use the IRS DRT contact the Office of Financial Aid.

2014 IRS Federal Tax Return Transcript. To obtain an IRS tax return transcript:
